Monday, June 8, 2020

All Commissioners are in today.

DES/911 Coordinator Brophy was in to give an update.

Planner Dringman presented the Feathers COS for review. Commissioner Roe made a motion to approve the aggregation of the Feathers lots in Yellowstone Meadows subdivision. Commissioner Moody seconded this and the motion passed with 3 ayes. She also presented the planning department budget.

Finance Officer Uehling was in to discuss the CARES Act reimbursement.

Weed Coordinator Weston stopped in to go over bids for the upgrade at the weed shop.

Tuesday, June 9, 2020
