Sweet Grass County Commissioner meetings are held in the office of the county commissioners in the Sweet Grass County Annex in Big Timber, Montana, unless otherwise noted in the minutes. The first Monday of each month a department head staff meeting will be held at 9:30 a.m. Claims will be reviewed and approved for payment every Thursday unless a conflict arises. At least one commissioner will be in the office from 9:00 a.m. to 5:00 p.m. daily unless they are at a conference or a meeting requiring them to be out of the office.

Monday, May 19, 2025

All Commissioners are in.

Fire Chief Kris Novotny and Contractor Heath Nation came in to discuss the Melville Fire Hall and the need for structural engineering due to the fact the new building will be designated as a Class 4 fire building and therefore will need an engineer's stamp. They discussed what the options looked like and how to include these additional costs.

The Commission also asked Kris Novotny about the lack of a street light at 5th and Mcleod next to the crosswalks and sidewalks that connect both the high school and the grade school.

Granite Technology stopped in with the new laptops for the Commissioners as the old ones were becoming obsolete with no software update available.

MACo Insurance provider Hope Barker and Josh Boka from Mountainview Insurance came in to discuss the property casualty insurance and the reasoning behind the increases.
