Monday, August 18, 2025

All Commissioners are in.

The Commission called Jason Rittal at MACo for clarification on fixed voted mills vs fixed dollar amounts plus inflation.

Road Supervisor Schuman stopped in to update the commission on the asphalt work on North Yellowstone Trail Road.

Josh Boka, with Mountain Insurance, stopped in to finalize the insurance.

Nancy from MACo returned the call regarding clarification on voted mills vs dollar amounts.

A fire was reported between Hump Creek and Stockade on private property.

Park County Commission came in to discuss getting together. They have concerns regarding the schedule of the sanitarian, they would like to see more cooperation between our respective counties and they would like to buy some gravel from the Miller Pit.
