Monday, July 21, 2025

Commissioner Roe is in the office. Commissioner Wallace is assisting the road crew.

Time sheets were reviewed and signed.

CHW/Mental Health Coordinator brought in the Catalyst For Change contract to be reviewed and signed.

A local resident came in to discuss the upper Main Boulder Road in Park County. He, and a group of folks who recreate up the Main Boulder and one of the Park County Commissioners have concerns over the road and they wondered if there was gravel in the Miller Pit that could be purchased and used for repairs above Four-Mile. Bryan Wells, Park County Commissioner, called to discuss some ideas for cooperation between Sweet Grass and Park County.

A local resident stopped in to discuss what the Commission was doing for economic development.
