Sweet Grass County Commissioner meetings are held in the office of the county commissioners in the Sweet Grass County Annex in Big Timber, Montana, unless otherwise noted in the minutes. The first Monday of each month a department head staff meeting will be held at 9:30 a.m. Claims will be reviewed and approved for payment every Thursday unless a conflict arises. At least one commissioner will be in the office from 9:00 a.m. to 5:00 p.m. daily unless they are at a conference or a meeting requiring them to be out of the office.

NOTICE: These minutes reflect the proceedings of the Board of County Commissioners. The official minutes are on file with the Clerk and Recorder (MCA 7-4-2611(2)(b).

Monday, July 28, 2025

All Commissioners are in.

Commissioner Roe called the meeting to order at 9:03 AM. The agreement and financial support for the Sweet Grass Chamber of Commerce was discussed. Commissioner Wallace moved to continue supporting the COC at the same level as before. Commissioner Moody seconded and the motion carried with 3 ayes. This meeting was recessed.

Commissioner Roe called the meeting back to order at 9:30 AM. The Catalyst for Change contract was discussed. Commissioner Moody moved to sign the agreement as reviewed by the County Attorney. Commissioner Wallace seconded and the motion carried with 3 ayes. The meeting was adjourned at 9:33 AM. This meeting was recorded.

The McLeod School informational meeting was called to order at 10:03 AM. The Grusins and their representatives were present. Superintendent of Schools Metcalf, several members of the McLeod School Board, the new teacher and the previous teacher, several parents and an adjacent landowner were also present. Discussion ensued about what options might be available for the school to continue, as the Grusins will not allow access through their property after the 25/26 school year. Snow removal, bus access, limited kids from McLeod District and parking continue to be problematic. The school board was tasked with discussing what options they feel they may have.

Tuesday, July 29, 2025

Commissioners Moody and Roe are in the office, Commissioner Wallace is assisting the road crew.

Collaborative Design called and discussed the Courthouse. They recommended we have a structural review done and then we can discuss the costs of renovation vs a new building.

The Commission received a request to send the preliminary plat review letters to their respective owners so they may forward them to DEQ.

Montana Land Reliance representative Garrett Titus and a local landowner stopped in to discuss the various types of conservation easements and what benefits they provide to landowners.

A local resident came in to complain about Rapelje Road NE of the Coulter/Weeks property.

Wednesday, July 30, 2025

All Commissioners are in.

Financial Officer Uehling came in to discuss budgets.

Commissioner Roe attended a grant meeting with Beartooth RC& D and several local stakeholders who have expressed interest in pursuing a Rural Community Development Initiative grant to provide some funding for some formal economic development in the county.

Thursday, July 31, 2025

Commissioners Moody and Roe are in the office.

Commissioner Wells from Park County called and visited with Commissioner Moody regarding the Main Boulder Road.

Heather McDowell from Sibanye Stillwater Mining Company came in to give some updates and discuss the "dumping case" they have filed against some of the companies that import PGM metals from Russia.

The Commission received a request to put up some delineator posts along North Yellowstone Trail before you get to Greybear Fishing Access. The road has very steep shoulders and it's hard to see the edge of the road during snowstorms.

Claims for the month of July totaled \$180,471.82. Payroll for the month of July totaled \$308,938.67.

Friday, August 1, 2025

The Commission updated the advertisement for road crew operator positions.

The DNRC Streambed Easement permit form was sent back with a check for the Flemming Bridge project.
