Monday, June 16, 2025

All Commissioners are in.

Commissioner Wallace is helping at the airport. Commissioner Moody headed to Forsyth for the MACo district meeting.

Commissioner Wallace went out to Hump Creek Road to look at the proposed encroachment driveway approaches to the county road for the Hendricks/Bakke subdivision.

Tuesday, June 17, 2025

Commissioners Moody and Roe are in.

Brandon Duffey of Great West Engineering opened the bids for the Flemming Bridge Replacement Project. Darby with TCA, one of the contractors, and Lloyd Rue, an interested party, were also present.

All bidders included notation of the addendum and proper security.

The engineers' estimate including the beams which have been ordered is \$739,275.00. Brandon Duffey with Great West Engineering will review the bids for errors and make a recommendation.

John Durnel, with Senator Daines' Office, stopped in to discuss some of the tax credits within the budget reconciliation bill.

The county is requesting an increase of approximately 3% due to inflation. The library budget and fire budgets have not been prepared yet. The meeting was adjourned at 9:20 AM. The Commission was called back to order at 10:00 AM to review two encroachment permits requested by Beartooth Electric approximately 14 miles north of Reed Point.

Commissioner Moody moved to approve -

06-19-2025B – Direct bury of electric cable in the ROW on Stephen's Hill Road – No conditions.

Commissioner Wallace seconded and the motion carried with 3 ayes. The meeting was adjourned at 10:10 AM. This meeting was recorded.

Kevin Babcock and Justin Mackenzie with First West Insurance, our work comp carrier, came in to discuss our policy and the premium. We will be seeing a decrease due to our experience modification factor dropping to .74. This reflects good safety practices, and we will see a credit of \$16,286.00.

The Commission was called to order for the purpose of reviewing the Susie Creek subsequent minor subdivision. Planner Dringman and Jeremy Eaton with Travis West Engineering were also present. Commissioner Moody moved to approve the subdivision with conditions as presented by the planner. Commissioner Wallace seconded and the motion carried with 3 ayes. A request to further clarify the easement of the road was also included.

Planner Dringman presented the Cunningham/Fiechtner boundary relocation. Commissioner Moody moved to approve the relocation as presented. Commissioner Wallace seconded and the motion carried with 3 ayes. The meeting was adjourned. This meeting was recorded.
