Sweet Grass County Commissioner meetings are held in the office of the county commissioners in the Sweet Grass County Annex in Big Timber, Montana, unless otherwise noted in the minutes. The first Monday of each month a department head staff meeting will be held at 9:30 a.m. Claims will be reviewed and approved for payment every Thursday unless a conflict arises. At least one commissioner will be in the office from 9:00 a.m. to 5:00 p.m. daily unless they are at a conference or a meeting requiring them to be out of the office.

NOTICE: These minutes reflect the proceedings of the Board of County Commissioners. The official minutes are on file with the Clerk and Recorder (MCA 7-4-2611(2)(b).

Monday, June 30, 2025

Commissioners Moody and Roe are in.

A resident stopped in to complain about South Shawmut Road and Hannah Lane.

The Commission received multiple complaints on the status of the state spraying of weeds in the Right of Way. They are missing a large section, which is a wet area, next to Melville Road. The Commission and Weed Supervisor discussed some options.

Staff from Bridgemont Mental Health stopped in to visit about the services they offer.

Claims for the month of June totaled \$961,315.66. Payroll for the month of June totaled \$356,477.63.

Tuesday, July 1, 2025

Commissioners Moody and Roe are in.

Financial Officer Uehling came in to begin the process of reviewing the budgets.

The Commissioners, along with District Court personnel and Justice Court personnel, met with Collaborative Design via Zoom to discuss the next steps in a possible Courthouse remodel project. A possible timetable was presented as well as a very rough budget. If the project was started right away, the construction and design documents could be prepared and structural assessment completed. This would result in a possible start date sometime in May of 2026 with a very rough budget of 2.4 million dollars.

Wednesday, July 2, 2025

Commissioners Moody and Roe are in. Commissioner Wallace is helping the road crew.

The Commission was called to order at 9:12 AM, Clerk and Recorder Curry read the minutes from March 31st through May 30th, 2025. Commissioner Moody moved to approve the minutes with corrections. Commissioner Roe seconded and the motion carried with 2 ayes. The meeting was adjourned. This meeting was recorded.

Commissioner Moody received an email from a resident up Swamp Creek Road who was concerned with the amount of traffic driving up the road in an attempt to get into the Crazy Mountains and Half Moon Campground which is located on a different county road. She wondered if we could put up some sort of signage at the intersection of HWY 191 and Swamp Creek Road indicating that the road was a dead end with multiple private roads with no turn arounds available.

Claims were reviewed and signed for the week.

Thursday, July 3, 2025

Commissioners Moody and Roe are in.

A local resident from Melville came in to talk about a cattleguard that he felt should be replaced on Donald Road.

Josh Sommer, the Airport Engineer, sent us an updated CIP to be signed and returned.

Commissioner Roe called the meeting to order at 2:01 PM to review and sign the DNRC State/County fire protection plan. Commissioner Moody moved to approve the agreement as presented. The motion was seconded and carried with 2 ayes.

The checks were reviewed and signed.

Commissioner Roe worked with the AREA II director and some of the executive board members on an issue brought forth by the Musselshell County Council on Aging.
