Monday, June 9, 2025

All Commissioners are in.

DES/911 Coordinator Brophy is in to discuss some of the challenges of the Sheriff's office radios and the lack of response by the consultant.

Marc King, the MSU Extension Agent, came in and presented his budget.

County Attorney Dringman presented his office's budget.

A mental health client came in to complain about a perceived denial of services.

Tuesday, June 10, 2025

DES/911 Coordinator Brophy presented the 911 budget and the communication budget.

Commissioner Roe attended a MACo Budget meeting via Zoom.

Assistant Planner King came in to do the Junk Vehicle Budget.

Justice of the Peace Connolly and Clerk DeMars presented Justice Court, Court Compliance and City Court budgets for review. They also requested that the county - salary committee be reconvened to modify and rescore several of the jobs.
