At least one commissioner will be in the office from 9:00 a.m. to 5:00 p.m. daily unless they are at a conference or a meeting requiring them to be out of the office.

Commissioner Roe attended a Crazy Mountain Collective meeting followed by a Zoom meeting with Beartooth RC&D.


Friday, March 20, 2026
